Main duties:

You will be based mainly on our in-patient psychiatric units. The aim of this placement is to offer an experience which combines in-patient work with some exposure to the interface between community psychiatry and in-patient work. You will also have the opportunity to experience outpatient work by attending clinics with the consultant, potential emregency home visits and mental health act work.

The trainee will clerk patients, assess mental and physical states, monitor progress of the patients' mental health and response to treatment, obtain collateral histories and liaise with colleagues in other teams. The trainee will have a fairly flexible timetable and will need to work closely with the team to prioritise tasks and resources. Their work will be supervised at all times by senior doctors and senior nurses.

Educational Activities

Regular weekly academic sessions: these will provide the trainee with opportunities to present cases or journals. Sessions will include audit and research sessions. They will be involved in the teaching of medical students. There will be opportunities to discuss cases with members of the multidisciplinary team eg consultant, clinical psychologists, community nurse, in-patient nurses, dieticians, and other medical colleagues. They will gain expertise in the assessment and management of a variety of mental illness and the interaction of these disorders with physical health. At the weekly ward rounds they will get the opportunity to present cases so their history taking and examination skills can be improved.

Other Comments (if appropriate):

This post will be based at Highbury Hospital, Rowan one within the acute care network of the Working Age (General Adult) service. The unit comprises of 4 in-patient acute wards (Rowans and Redwoods, single sex wards) and a Psychiatric Intensive Care Unit (PICU), male only. The Acute wards have combined total of 64 beds while the PICU has 10 beds. Rowan one has 2 consultants and 2 junior doctors who for the most part were GPVTS trainees. Other wards have similar doctor numbers. There was no secterization of the ward and patients could be from any area in nottingham and it will be a male only ward. There will be oppurtunities to cross work on the female only ward, Rowan 2 for added experience. There will also be the option of weekend on-call work which will involve shadowing the senior trainees.

The foundation trainee will have an opportunity to satisfy requirements of the Foundation Curriculum and will be supported by the trainees working on the unit. This post will also provide plenty of opportunities for directly supervised practice and supervised learning events (eg on ward rounds and reviews) as well as work-place based assessments. The Highbury hospital placement is an established training resource for our trainees, with education and innovative practice firmly embedded in its multidisciplinary work culture, thus readily providing a safe learning environment

Apart from mental health-related issues, working with this group of patients also presents an opportunity to deal with associated primary and secondary health issues as they arise.

This work will be supervised by a consultant psychiatrist and will involve the further development of wider multi-disciplinary working. General areas:

The foundation doctor will be involved in the assessment of patients admitted to the acute ward, Rowan one predominantly; this will include the taking of a full history, including medical history, as well as other related areas, and mental state and physical state examination. They will be involved in the organisation of further investigations and referrals to other professionals. They will have the opportunity to present their findings.

Specialist areas:

They will be involved in further consultation with other allied professionals such as neuropsychiatrist, psychologists, neurologists, dieticians, and physiotherapists.

They will be involved in risk assessment of acutely unwell and behaviourally disturbed patients on the ward.

Work as a part of a multidisciplinary team.

The trainee will take part in the regular review of working age adults with psychiatric and physical health problems and take an active part in the management and follow-up under supervision.
