## Main duties:

The post is based in Linden Lodge Neuro Rehabilitation Unit, which is a 25 bed in-patient rehabilitation unit for adult patients who have neurological conditions. The majority of patients are admitted from Queens Medical Centre either in Neurosciences or Major Trauma Unit. The unit has two full time consultants in Rehabilitation Medicine, Speciality Doctor (Staff Grade), F2 trainee and most of the time Specialist training rehabilitation (Specialist Registrar). The unit also has a multidisciplinary team of nurses, dieticians, occupational therapists, physiotherapists, psychologists and specialist nurses.

The foundation trainee will be able to satisfy the requirement of the foundation curriculum and will be supported by consultants and other medical staff in the unit. The placement of direct supervision of clinical practice and work place based assessments to help the trainee to meet their intended learning objective for foundation programme.

The medical team at Linden Lodge are responsible for medical management of patients at Linden Lodge in liaison with the multidisciplinary team. The duty of the post includes clerking admissions, attending ward rounds, investigation and management of common medical problems that are associated with patients with neurological conditions in addition to attending admission meetings and case conferences as appropriate.

### **Educational Activities:**

- 1. Learning opportunities including developing experience in neurological conditions and rehabilitation, particularly taking medical history and examination of common neurological conditions.
- 2. Learning management of bladder and bowel problems.
- 3. Learning how to work with the multidisciplinary team, both as team player and team leader and working with people from various disciplines and professional backgrounds as part of interdisciplinary teamwork.
- 4. Attending neuroscience meetings and referrals at the Queens Medical Centre to improve the theoretical knowledge of neurological conditions.
- 5. Attending F2 training every other week at the Post Graduate Centre at the City Hospital.
- 6. Opportunity to attend other activities within Rehabilitation Medicine including Neuro Rehabilitation Clinic, Major Trauma Rehabilitation and Amputee Rehabilitation Clinic as part of the exposure to rehabilitation.
